House Rules

1. Introduction These House Rules govern the Maggie's Place – A Resource Center for Families Duck Race. By participating, entrants agree to comply with these rules.

2. Eligibility

- Participants must be at least 19 years of age to purchase a ticket as per local regulations. Tickets cannot be ordered in the name of a minor.
- Paid employees of Maggie's Place are ineligible.

3. Entry and Ticketing

- Each ticket corresponds to one uniquely numbered rubber duck.
- Ticket sales will close on May 30th, 2025 at 11:59pm
- A minimum of 250 numbered ducks must be sold for the race to run.
- There will be a maximum of 1000 ducks sold
- Prices will be as follows: 1 duck for \$10, 3 ducks for \$25, 7 ducks for \$50 and 15 ducks for \$100.

4. Conduct of the Race

- All numbered rubber ducks will be released into the designated racecourse in Lepper Brook at Victoria Park located at 29 Park Road, Truro, Nova Scotia.
- The ducks will move naturally with the water current; no external interference is permitted.
- The first duck to cross the designated finish line will be declared the winner, followed by second and third place.

5. Prizes

- Prizes will be awarded to the entrants whose ducks place in the top positions.
- 1st Place \$1,000

2nd Place – 1 year family membership to the Rath Eastlink Community Center (valued at \$1,392). There will be no circumstance in which cash in lieu of this prize will be offered.

3rd Place - \$100

• Winners do not have to be present at the race to claim their prize. We will be contacting winners through the phone number and email address provided.

• If the winners cannot be contacted within 90 days, the 4th place finisher (and following with 5th and 6th etc.) will be notified and receive the unclaimed prize.

6. Disqualification

- Any tampering or external interference with the race will result in disqualification.
- Any entrant found violating the rules may be barred from future participation.

7. Postponement or Cancellation

• This race will be running rain or shine. The organizers reserve the right to postpone the Event due to unforeseen circumstances (e.g., extreme weather, safety concerns).

8. General Conditions

 The Released Parties (defined below under "RELEASE OF LIABILITY") are not responsible for: (1) Entries which are stolen, lost, damaged, illegible, given away or no longer in the purchaser's possession, (2) Entries that have been or may have been tampered with or re-sold in violation of these Official Rules; (3) Entries or payments that are delayed, misdirected, undelivered, not fully captured, or garbled as a result of any failure or problem whatsoever with the availability, functionality, operability or use of any network, server, ISP, website, computer, telephone, cable or satellite modem or connection, hand held mobile device or any other computer equipment or connection, whether or not caused by site users, tampering, hacking, or by viruses, worms, or malfunctions affecting a network, server ISP or any equipment or programming used in or associated with the Raffle; (4) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (4), "Errors"), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying Potential Winners, determining Official Winners, or announcing or delivering Prizes; or If any portion of the Raffle is compromised, in Maggie's Place sole judgment, by a virus, worm, bug, non-authorized human intervention or other causes which, in Maggie's place sole judgment, corrupt or impair the administration, security, fairness or proper play of the Raffle, or the proper submission or capture of Entries (collectively, a "Compromising Event"), then Maggie's Place reserves the right, in its sole discretion, to suspend, modify or terminate the Raffle, and to select winners from all eligible, non-suspect Entries
